



### Accessibility Standards


- Accessibility standards mandate how businesses and organizations provide accessible services to students, employees, visitors and community members.
- Organizations will be required to meet accessibility standards as outlined in the legislation.











# **Regulatory Rights**

- The rights of persons with disabilities are protected under both the Canadian Charter of Rights and Freedoms and Ontario's Human Rights Code.
- The goal behind Accessibility is to create an inclusive society where everyone can participate to their full potential.



#### As Accessibility Increases:


- 1. People with disabilities will bring their talents to the workplace.
- 2. Youth with disabilities will have more opportunity for educational achievement.
- 3. Seniors will live more fulfilling lives.
- 4. Consumer spending by person with disabilities will rise.











### Accessibility Standards

- Businesses and organizations that provide goods and services to people will need to meet certain standards in 5 major areas.
- All 5 standards are linked to the common goal of full accessibility by 2025 and should be treated collectively.











### **Customer Service**

All businesses and organizations that provide services to people will be required to make their customer service operations accessible to people with disabilities.

It's about understanding that people with disabilities may have different needs.

- Allow assistive devices in your workplace. (wheelchair, walker, oxygen)
- Allow service animals.
- Welcome support persons.
- Openly share when accessible services are not available.
- Invite customers to provide feedback.
- Put plan in writing and let customers know how to find it.
- Offer plan in accessible format (large print/braille).









### **Transportation**

#### **Standards Include:**

- Verbal announcements to notify route, direction, destination and major stops.
- Not charging people with disabilities a higher fare or a fee to store their wheelchairs, canes and walkers etc.











# Information & Communication

Will help people with disabilities access sources of information.

#### Examples:

- Screen readers help people with vision loss access more websites.
- Expand large print and digital collections in public libraries.
- Provide students with course information and learning materials in accessible formats.
- If your organization prepares emergency procedures, plan or public safety information, you will need to provide information in accessible formats, such as large print.









# **Employment** (Workplaces)

- The accessibility standard for employment will help remove barriers and enhance support.
- In the workplace, it will allow for continuity between all employees. It will make accessibility a normal part of finding, hiring and communicating with employees with disabilities.
- Organizations need to provide their employees with emergency response information that is tailored to the employee's need, if the disability requires it.









# Building Environment (Building & Spaces)

 Goal is help remove barriers in buildings and outdoor spaces for people with disabilities.











### **Public Buildings**

**Consider the following:** 

#### Cognitive

- Color coded signs
- Less information on signs
- Clearer legibility

#### Hearing

- Audible wayfinding
- Text Telephones
- Volume control phones
- Less background noise

#### Vision

- Braille signage
- Color contrast signage
- Sign placements

#### **Physical**


- Wheelchair accessible
- Sign placements
